Members approved the following to commemorate Cllr Fryer's life:

An additional plaque on the Boat House - '*In memory of Cllr Rob Fryer, Mayor of Warminster 2012 – 2013 and 2017 – 2018*'.

The planting of a hornbeam in the Lake Pleasure Grounds.

Members had a further debate about the installation of a commemorative bench in the park for Cllr Fryer, this should cover the cost, circa £750, location and whether council would approve this going forward.

Members unanimously agreed that this should be a discussion at the next Full Council meeting, for all commemorative ideas for past councillors going forward.

PE/23/062 100th Anniversary of the Lake Pleasure Grounds

Whilst members understood the reasons for the Centenary Event in the park to be ticketed in view of the health and safety issues, new anti-terrorism laws, advice from the Police and from the Town Councils' insurers they felt that this decision should be discussed by all members with a full report at Full Council.
