Unitary Councillor Tony Jackson congratulated the Town Council on achieving Green Flag status, a great accolade for the town. Secondly, he wanted to speak about agenda item 11.2, Regeneration Working Group for Warminster, saying that he would strongly advise the council to send a representative to join the group and it would make sense for this to be a member of the Town Development Committee.

Phil Seddon, Town Crier for Warminster, spoke on agenda item 12, Mayoral Robes, saying that he thought providing robes was a good idea. When Mayors are attending Civic functions wearing robes they look the part and the pageantry and splendour is a sight to behold.

#### FC/17/050 Neighbourhood Plan Policy Review Working Group (NPPRWG)

FC/17/050.1 The draft minutes were noted.

**FC/17/050.2** The members had a lengthy debate regarding the Wiltshire Council Presubmissions consultation. Councillor Nicklin led the discussions explaining all the points that the Neighbourhood Plan Policy Review Working Group



(NPPRWG) considered and were included in their minutes which had been distributed to all members for their perusal prior to the Full Council meeting. Councillor Nicklin proposed that the NPPRWG comments on the Draft Housing Sites Allocation and the 24 comments on the Proposed Settlement Boundary be submitted in response to Wiltshire Council's consultation. He also asked that a Wiltshire Council officer be invited to meet with the NPPRWG so that they could explain their reasons for the comments. Seconded Councillor Jolley, voting unanimous in favour.

#### FC/17/051 Representatives to External Bodies

#### FC/17/051.1 Market Towns' Forum

Councillor Fraser advised the committee that she had been representing the Council at these meetings and was happy to continue. Members agreed unanimously for her to continue.

## FC/17/051.2 Regeneration Working Group for Warminster

Councillor Nicklin told the members he was happy to put himself forward for this meeting. Councillor Davis nominated Councillor Nicklin to attend the Regeneration Working Group, along with Councillor Sue Fraser who is the Council's representative to the Warminster Area Board. Seconded Councillor Jolley, voting unanimous in favour.

# FC/17/051.3 Local Youth Network (LYN)

Councillor Brett advised the committee that he was happy to put himself forward to be the Warminster Town Council representative. Councillor Jolley nominated Councilor Brett to be the Local Youth Network representative for Warminster Town Council. Seconded Councillor Robbins, voting unanimous in favour.

#### FC/17/052 Mayoral Robes

The members had a lengthy debate regarding the Mayoral Robes. Most of the members agreed that this was the way forward for the Town Council and it was important for the Mayor to look the part and to be proud to represent the town at certain events. Councillor Jolley proposed that Warminster Town Council thank Lesley Fudge for her kind offer to make the robes and that a maximum cost of £750 be spent on all materials for a unisex Mayoral Robe, hat and gloves. Seconded Councillor Macfarlane, voting in favour 9, against 1, abstentions 0. Motion carried.

#### FC/17/053 Lake Pleasure Grounds (LPG)

Councillor Macfarlane proposed confirmation that the 'Lake Pleasure Grounds' should continue to be the primary name for the park to avoid the expense of changing signage outside and within the town. Any signs and new leaflets should refer to 'Lake Pleasure Grounds' with 'Warminster Town Park' as a subtitle. Seconded Councillor Davis, voting unanimous in favour.



## FC/17/054 Standing Order 32

Councillor Robbins proposed that members agree to the adherence of standing order 32, 'A member shall stand when speaking unless permitted by the Chairman to sit on account of infirmity'. Seconded Councillor Jolley, voting unanimous in favour.

# FC/17/055 Civic Reception and May Day Celebration in the Park

The members had a lengthy debate about the possibility of a Civic Reception and May Day celebration. They agreed that they would like to proceed with this as a means of acknowledging the enormous contribution volunteers make to the life of Warminster. There were some concerns raised about the costings of the events. Councillor Macfarlane proposed that members agreed to the principle of a Civic Reception and May Day celebration and the availably of £750. The item should be taken forward to be discussed at the next Finance and Assets meeting for some additional funding as there were concerns that the amount set aside would not be sufficient. Seconded Councillor Davis, voting unanimous in favour.

In view of the confidential nature of the business about to be transacted, the public and press were temporarily excluded and they were instructed to withdraw from the meeting at 8.25pm
