Extract from PAC Minutes Monday 18th May 2015

The Members had a lengthy debate about this application and whilst they fully understood the residents' concerns they felt that these units would be good for the town and bring in new businesses and provided the issues were addressed they could support it. Councillor Fraser proposed that Warminster Town Council recommend approval for this application but request that adequate and continual screening is provided to reduce the light and noise pollution, Seconded Councillor Jolley, Voting unanimous in Favour.

Members were pleased to welcome new business to the town, but reiterated the conditions that were requested on the original plans.
