PC/17/072 Reports from Unitary Authority Members

Councillor Jeffries spoke on behalf of the Unitary Members Councillor Pip Ridout advising the committee that she had spoken to James Taylor, the planning officer for application 17/08220/ VAR Furnax Lane condition variation. His response to the committee's concerns were as follows: "I am trying to negotiate with the developers on this site. It was variation of conditions imposed on 15 starter units at the southern end of the business park. I really don't have concern over the change to materials and can live with the removal of the BREEAM condition. I won't accept the change to hours based on the information I have from the developers, i.e. nothing really, the EPO objection and the local resident's complaint. The local resident objection (Ian Frostick) has stated that he is happy to follow officer recommendation on materials and BREEAM. As long as I stick to this line are you happy to let me use delegated powers?"
