DS/18/069 Reports relevant to this Committee from Unitary Authority Members

The Clerk advised members that Wiltshire Unitary members for Warminster were still liaising with officers and their fellow Unitary members respectively regarding the Warminster playground transfers.

DS/18/070 Clerk's Report: Town Park and Associated Land

The reported was noted and the following points raised:

DS/18/070.1 The Clerk highlighted that the Council's grounds maintenance contracts are due for renewal on 1st April 2019 and that details would be presented to members at the next Committee meeting. The contracts had been novated from Wiltshire Council and extending the contract length was included in the terms. (Item 7 m refers).

DS/18/070.2 Whilst it was acknowledged that the Council already advertises events in multi-media format, including Facebook, Visit Wiltshire, Town Talk, flyers and banners, more advertising of events in the park such as the model boat club and the fun runs was agreed as a good idea. The Clerk would action.

DS/18/071 **Tree Trail – Request for Funding**

Councillors thanked and commended Harriet James for producing an enthralling booklet.

Councillor Nicklin proposed approval of the publication of the 'Tree Trail' with an initial print run of 1000 copies, seconded Councillor MacFarlane, voting unanimous in favour.

Lake Pleasure Grounds (LPG): Paddling Pool DS/18/072

Members debated the future of the paddling pool and it was unanimously agreed that the paddling pool would remain whilst acknowledging that it was a wonderful asset for the LPG and Town. Members further noted; to keep the pool open, further repairs may be required in the interim whilst a significant rebuild/replacement was planned; the work may have to be phased; the pool was number two on the Community Infrastructure Levy (CIL).

Councillor MacFarlane proposed to delegate the research, costings and funding of option 4 (to replace the existing pool) to officers for presentation at the next Committee meeting, with the understanding that Option 2, repairing the pool to keep it open, will also be pursued in parallel, seconded Councillor Fraser, voting unanimous in favour.

DS/18/073 **Draft Budget**

Noted.

Members agreed to add/increase the following items on the 2019/2020 draft

DS/18/073.1: Councillor Nicklin proposed increasing the budget line 210/4036, repairs and renewals in the park by £5,000, seconded Councillor Jeffries, voting in favour unanimous.

DS/18/073.2: Councillor Jeffries proposed a new budget line to fund replacement of missing/damaged bins currently under the remit of Wiltshire Council if they are going to continue to empty them, seconded Councillor Fraser voting unanimous in favour.

DS/18/07.3: Councillor Jeffries proposed the new bin replacement budget line be £5,000, seconded Councillor Fraser voting unanimous in favour.

Councillor Nicklin proposed the CIL Working Group be asked to consider funding replacement of missing/damaged bins currently under the remit of Wiltshire Council if they are going to continue to empty them, seconded Councillor Fraser voting unanimous in favour.
