PC Pelling outlined the work being undertaken to reduce knife crime, tackle anti-social behavior in the Lake Pleasure Grounds and stop late night rowdy behavior in Weymouth Street. He praised the work of the CCTV team which had helped secured excellent results. The increase in the Police precept will pay for 42 more officers across Wiltshire and result in an increased community policing presence in Warminster.

Cllr Ridout proposed that members retrospectively approved the formation of the Boundary Review Working Group, seconded Cllr Doyle, voting unanimous in favour.

Cllr Nicklin proposed that the Council make a submission to Wiltshire Council and the Local Government Boundary Commission for England in line with the Working Group's recommendations. In particular, that the Town Council supports the view of the Unitary Councillors who represent the Warminster Area. The council prefers the name Warminster North and Rural (for the relevant Division). The council also wishes to have 14 Town Councillors, with 4 each in East, West and Broadway wards and 2 in North ward, seconded Cllr Ridout, voting unanimous in favour.

FC/18/116 Warminster Town Fairtrade Status: Renewal

Cllr Brett proposed that members agree to set up a working group to consider applying for renewal of Town Fairtrade Status, to include co-opted members sought via social media, seconded Cllr Fryer. Voting in favour 3, against 7 abstentions 2, the motion was not carried.

Members agreed that they did support Fairtrade status for the town and would be happy to support the Fairtrade Group in their search for volunteers using the Council's social media, the Clerk to liaise and action.
