Kay Whatley-Gibbs spoke in objection to application No.19/12156/FUL, her notes are attached to the minutes.

Len Turner agreed with the all the comments regarding Wren House application. He also spoke in objection to application No.19/12156/FUL saying that this area used to be a dump and no proper survey had been undertaken for many years regarding the structure of the soil. The site drains into the River Weir and provision should be made to carry away the surface water. However, Warminster would welcome more jobs in the area.

Cllr Spender proposed refusal due to the traffic impact on highway safety and overdevelopment of the site, seconded Cllr Doyle, voting in favour for refusal 6, against Nil, abstention1. Motion for refusal carried.

Cllr Nicklin proposed that Warminster Town Council had no objection to the development providing the Wiltshire Council planning officers have completed all the correct surveys on the area including historical use of land, contamination of the water and flooding issues, seconded Cllr Brett, voting in favour 6, against Nil, abstention 1.
