### TD/19/066 Community Area Transport Group (CATG)

Members had a lengthy debate about the projects on the Warminster CATG.

One of the items on the list were concerns over issues in Woodcock Road and members were very concerned that Kingdown School had not submitted an up to date travel plan.

Cllr Davis proposed the committee endorse the view of CATG that they should encourage Kingdom School to complete an up to date travel plan and were concerned about the absence of a travel plan and that this item to be bought back to the next Town Development committee meeting for further discussion, seconded Cllr Ridout, voting unanimous in favour. The remainder of the report was Noted.

It was noted that Warminster now had two items in the local CATG top 5 priorities – the 30mph speed limit on Small Brook Road and the bollards at the junction of Portway and High Street.

#### TD/19/067.2 Carsons Yard

Cllr Pitcher proposed that as Carsons Yard is a private, unadopted road, the town council is not empowered to do anything that would address the concerns of the resident, no action could be taken and the resident who raised the issue to be advised accordingly. Seconded Cllr Fryer, voting unanimous in favour.
