PR/20/008 Corona Virus

Members were pleased that the skatepark had been reopened and that it was being used sensibly, adhering to the Government guidelines. Cllr Davis advised members that there had been an issue between skaters and members of the public before it was widely known that as a sport the skatepark had been opened. Members also wished for it to be clarified that the public conveniences were still closed and would be until a further guidance was forthcoming from Government. At the moment, the Government's advice is to allow outdoor exercise, but not to encourage the use of indoor areas where there is 'a higher risk of close contact and touching surfaces', which clearly applies to public toilets. The report was **Noted**.

PR/20/009 Outdoor Gym

Cllr Brett reminded members that this had been discussed at a previous meeting where it was asked that more information be provided before making a decision. The report attached to the agenda is comprehensive and provides four quotes for very similar sets of gym equipment.

Cllr Spender proposed for members to agree to appoint Preludic to install outdoor gym equipment in the Lake Pleasure Grounds, Town Park at a cost of £11,900, seconded Cllr Davis, voting 5 in favour, 1 against and Nil abstention. Motion carried.
