Members had a lengthy debate about the purchase of a ride on mower. The Park and Open Spaces Manager answered all the questions members asked. Members referred to the battery powered mower being in line with the councils green policies.

Cllr Robbins proposed to recommend to Full Council the purchase of the battery- powered Mean Green Mower at a cost of £25,839 plus VAT, seconded Cllr Davis, voting in favour 4, abstention 1, against Nil. Motion carried.

If this falls within the £1800 budget set aside, then it can go ahead. Further quotes can be sought using local suppliers for the following years. Seconded Cllr Robbins, voting unanimous in favour.
