Cllr Davis said he disagreed with that advice and he would challenge the ruling.

Cllr Spender said he agreed with the points made by Cllr Davis.

Cllr Batchelor said he had grave concerns about the process. [for accessing confidential HR papers]

Cllr Nicklin said he would like to reassure other Councillors, that until a committee had decided something these matters could not be circulated to other committees or Full Council. The HR Committee was just following the process in the correct order for the way in which a council operates.

HR/20/029 Clerk's Report

HR/20/029.1 Members Noted that the council reception and Civic Centre were currently closed. Council officers continued to provide services from 8.30am – 4.30pm Monday – Friday inclusive, working from home and were available via email and telephone. The Council would continue to review the Government's advice and would amend current working practices and services as necessary. The café and CCTV remained unaffected.
