#### 5. Casual Vacancy Co-option of a Town Councillor (Warminster Broadway)

Following the resignation of Councillor Paul Batchelor, Wiltshire Council has formally confirmed that no requests were received to hold a by-election and that the Town Council is able to co-opt a new Town Councillor to represent the Warminster Broadway Ward. This casual vacancy has been advertised and three candidates have come forward: The Revd Andrew J Cooper, Asa Henry and Philip (Phil) Keeble.

Application forms for each candidate are **attached**. Each candidate is qualified under the Local Government Act 1972 s.79

The following process will take place:

- i) Each candidate will be invited to make a short statement in support of their application (approximately.3 minutes) about how their membership of the Town Council would benefit the Council itself and the community
- ii) The Mayor will invite Councillors to ask questions and for candidates to answer (approximately 6 minutes in total.)
- iii) Once each candidate has been through this process then Councillors will vote to determine the successful candidate.

Members to vote on which candidate they wish to co-opt to Warminster Town Council.


