Parks and Estates Committee 24th May 2021

Lake Pleasure Grounds

- 1 Lake: The Japanese Knott weed on the islands has been treated. This will be treated again in the autumn.
- 2 Pavilion Café: Continues to offer a takeaway service and has just recruited seasonal staff for the busy summer period.
- 3 Skatepark: is open inline with Covid regulations and being well used.
- 4 Public Toilets: Central Car Park public conveniences: All toilets are open.
 Lake Pleasure Grounds public conveniences: all toilets are open.
 Risk assessments have been updated in line with the current situation.
- **Paddling Pool**: Currently Closed. Awaiting final decision by Full Council on its replacement by a splash pad.
- 6 Elizabeth Collyns Garden: Fairfield Farm Collage have resumed their weekly maintenance visits.
- 7 Flower Beds: The summer bedding will be in at the beginning of June; the local primary schools will be planting again this year. Wildflower seed mix has been sown in the other beds. Wildflower seed mix has also been sown along fence lines as an alternative to chemical sprays.
- 8 Boats on the lake: Will recommence once regulations allow.
- 9 MUGA area, the boat house: Nothing to report.
- 10 Putting green: See agenda.
- 11 Tennis courts: Easter Tennis Camp was very successful. The fencing has been repaired in a couple of areas. A refurbishment project will be bought to committee in the future.
- 12 Tree works: Most of the work has been completed. The final work will be caried out over the next month or so.

Outside Services

- 13 Play Areas: Open in line with guidance on Covid19.
- 14 Closed churchyards: Grass cutting is continuing.
- 15 Hanging baskets and Tubs: Wildflower seed mix has been sown in all tubs around the town. Hanging baskets will be delivered and put up at the beginning of June.
- **Sweeper (Basil Brushes):** Continues to clean the town. Has been working with the barrow man to remove the weeds at Portway and on Boreham road. Will be used to water the hanging baskets.
- 17 Street Furniture: Replacement bin parts have been ordered along with replacement bins as agreed at the last Parks and Recreation committee meeting.

Putting Green Area

Recommendation

Members debate the options for the putting green and resolve which option they wish to undertake.

Purpose of the Report

To provide members with information to make an informed decision.

Background

In 2017 Warminster Town Council re-opened the putting green in the Lake Pleasure Grounds. This is a 9 hole course. Members of the public were able to hire putters and balls from the Pavilion Café for a small fee of £1.50 per round. The putting green was not a major income generator but did offer something else for visitors to enjoy whilst in the park.

Due to the Covid pandemic the putting green did not reopen in spring 2020 and has remained closed.

The area has become a popular picnic area during the pandemic with 3 picnic tables placed in the area. Particularly with the café only offering a takeaway service.

Findings

Officers have noted the popularity of the area for picnicing and believe this will continue throughout the summer particularly as the Pavilion Café will continue to offer a takeaway service.

The putting green requires a large amount of staff time and equipment to maintain. The cost of which is not covered by the playing fees.

Members of the public have frequently approached officers to ask for more picnic benches within the area. Officers believe the Broxap Sneyd Hill picnic bench will be appropriate. (see picture) These cost circa £400 each.



Officers considered changing the putting green around to allow for an area to be used for picnicking and feel a nine whole course is still possible. See map.

Conclusion

Officers believe there are three options for members to consider:

- 1. Leave the area as a putting green and remove the picnic benches This will not satisfy the public's desire for more picnic benches.
- 2. Change the use of the area to picnicing only This will satisfy the need for more picnicing areas but will mean the putting is lost.
- Divide the area into two, one for picnicing the other for putting This will satisfy the need for more picnicing and also keep the putting for those who wish to play.

Financial and Resource Implications

Depending on the option.

- 1. No additional cost
- 2. Additional benches will be needed to fill the space. These cost circa £400+ VAT each.
- 3. Additional benches will be needed, these cost circa £400+ VAT each. The area would need to be divided by additional shrubs at a cost of £200.

Legal Implications and Legislative Powers

WTC has the power to provide this service under the General Power of Competence.

Environmental Implications

Officers cannot foresee any negative environmental impact as a result of this.

Risk Assessment

WTC will carry out risk assessments for any work undertaken.

Crime and Disorder

Officers are not aware of any issues the council should consider under the Crime and Disorder Act.
