

There was no public participation.


#### FC/21/066 Reports from Unitary Authority Members and the Police

Pc Howick gave her apologies for being unable to attend the meeting. In a written report she impacted that since the last meeting:

Licencing visits are continuing and no reported problems, all local establishments are being contacted to start Pub Watch back up again.

Community Speed Watch is continuing with all the schemes in our areas. Neighbourhood Pc conducted checks at Woodcock Road on 20th July, three drivers were given words of advice and one driver was issued with a fixed penalty notice for excess speed, all drivers were local to Warminster. Good response from Facebook post and the team will be out in more areas carrying out checks from suggestions on the post.

On afternoon of 20th July, excellent work by Warminster CCTV who alerted the Police Control Room to two males shoplifting from Boots in the Market Place, Neighbourhood Team were able to stop the vehicle in the Market Place and arrest the two males, following search of the vehicle a large amount of stolen property has been recovered we believe these items are from several other stores across the area. Following checks on one of the males he was found to be wanted for similar offence in another County. Once all enquires were completed, both males were interviewed by our response colleagues and they were both charged with theft and bailed to court. The wanted male appeared before court in the morning. Great teamwork by all involved.



Now the Summer Holidays have started increase patrols will be taking place around the Town Park to help reduce any reports of ASB.

Operation Sherpa continues. Its focus is dealing with road traffic offenses and continues to follow up on and deal with reports.


### FC/21/072 Standing Orders and Code of Conduct Working Group
