TD/21/044 Chairman's Announcements

Cllr Davis updated members of communication received regarding industrial action by employees of the refuge collection company. It would have affected many household waste collections. This planned industrial action will now not go ahead.

TD/21/046 Public Participation

Mr Lusty, of Linked Resourcing, The Old Silk Works spoke on item TD/21/050.1 detailing the issues that the delivery vehicles and other road users experience on a daily basis at the area around The Old Silk Works.

TD/21/047 Reports from Unitary Authority Members

There were no reports from Unitary members.

TD/21/048 Tynings Allotments

Members noted the minutes of the meetings held on 16th November 2021.

TD/21/049 Community Area Transport Group (CATG)

Members noted the Minutes of the Warminster CATG meetings from Wednesday 27th October 2021 and Wednesday 19th January 2022.

TD/21/050 New Highway Issues

TD/21/050.1 Beech Avenue/Alcock Crest

Members resolved to support the WR1 request for double yellow lines on both sides of the road at the Old Silk Works, to be submitted to the Wiltshire Council.

TD/21/050.2 Sambourne Road

Members resolved that they would take no further action on the parking of a large vehicular horse box on Sambourne Road as the vehicle in question is legally parked.

TD/21/050.3 Traffic Lights Town Centre - Market Place Members resolved that they would take no action on the request to change a pelican crossing to a zebra crossing as they felt that this would cause increased issues with traffic.



TD/21/050.4 Woodcock Road to entrance to Woodcock Lane/Robins Close

Members resolved not to support the WR1 submitted by a local resident regarding frequent traffic jams, damage to vehicles and safety risk to children walking to and from school as they felt that the provision of yellow lines would speed up traffic, making it less safe.

TD/21/050.5 Pound Street

Members resolved that they would take no action on the request to introduce traffic calming measures including a speed limit reduction below 30mph.

TD/21/050.6 Norridge View

Members resolved to invite the Highways Team to visit the site to ensure that, if yellow lines are to be placed, they are located in the appropriate position and length. Subsequently Warminster Town Council would file a WR1.

TD/21/050.7 The Maltings

Members resolved to defer the application for further investigations by councillors of the West Ward, in order to make the most appropriate potential changes to road markings.

TD/21/051 Smallbrook Road

Members resolved to communicate with CATG to find out what period of time and what evidence is need before a speed limit can be changed from 30mph to 20mph. Members also agreed that this item would stay on future agendas until an ultimate decision would be made.

Members noted the update from the working group and thanked the volunteers for their hard work.

TD/21/054 Update re meeting flooding issues in Warminster

Members noted the update and asked the Deputy Town Clerk to communicate with the Environment Agency and Wessex Water for an update on their short-, medium- and long-term plans for Warminster.

Members noted the minutes of the meetings held on Tuesday 14th September 2021 and confirmed the next meeting will be on Monday 14th March 2022.



TD/21/056 Cycle Path Working Group

Members resolved to adopt the three objectives from the cycle working group.

- To link schools and workplaces and community facilities into a cycle path network – not just for leisure cycling but to encourage people out of cars and into cycling and walking
- To ensure new housing developments have new cycle routes that integrate with the rest of the town and to ensure the updated Neighbourhood Plan means developers deliver cycleway improvements
- An Initial focus on converting suitable footpaths to cycle tracks as these are seen as 'easy wins' with a lower cost and higher prospect of delivery

Members also asked that the cycle path working group will be included on the mailing list to receive planning applications to then be able to present comment for Wiltshire Council to consider.

TD/21/057 Speed Indicator Devices (SIDs)

After several requests from members of the public for SIDs, members resolved to:

- Contact Wiltshire Council for a comprehensive set of existing
 Metro Counts which might be used to support SID's in Warminster
- Contact Wiltshire Council for their latest criteria and advise on installations of SID's
- Ask members to inform the town clerk of any locations in Warminster they feel would benefit from SID's
