# PE/21/060 Queensway Play Area, Football Goals

Councillor Macdonald had asked the committee to consider installing two mini football goals at Queensway Play Area.

Members resolved to purchase the goals at a cost of £1,000 - funding to come from Earmarked Reserves Play Areas.

# PE/21/061 The Beeches Play Area

At the Parks and Estate committee meeting on Monday 10<sup>th</sup> January 2022 members resolved to remove the fence at the Beeches and consult local residents to determine which play equipment they would like in the play area. Consultation with residents had indicated opposition to the removal of the fence as it kept dogs and cars off the play area.

Members resolved to ask officers to investigate the cost of replacing the dilapidated fence with a hedge and a knee rail and to bring the matter back to a subsequent committee meeting for decision.

#### PE/21/062 Moving the flagpole in the Lake Pleasure Grounds

Cllr Fryer had asked the committee to consider moving the flagpole by the Pavilion Café to nearer Weymouth Street.

Members resolved to purchase a new 6m flagpole that will be positioned in the vicinity of the Weymouth Street pedestrian entrance, at a cost of £1,000 - funding to come from Earmarked Reserves Open Spaces.

#### PE/21/063 Planting of Hornbeams in the Lake Pleasure Grounds

Cllr Fryer has proposed the following motion:

"To consider planting one or more Hornbeams in the Park and perhaps elsewhere. The appearance of Hornbeams is very rural and would therefore be suitable for a country town like Warminster. Perhaps this could be for the Jubilee." Seconded Cllr Parks.

# PE/21/067 Refurbishment of the Tennis Courts

All members had attended a briefing on 17th February 2022 to review options for refurbishing the Tennis Courts in the Lake Pleasure Ground.

**Clir Macdonald proposed the Committee recommend to Full Council that:** 

- Officers continue to liaise with the Lawn Tennis Association and Sport i) England about securing matched funding for refurbishing the Tennis **Courts**
- Officers are authorised to seek tenders for a refurbishment of the ii) **Tennis Courts and MUGA**
- iii) The inhouse model is the preferred option for running the refurbished **Tennis Courts.**

Seconded, Cllr MacFarlane.

Members voted 6 in favour, nil against and 1 abstention. Motion carried.

# PE/21/068 Path between the play area and the skatepark

The path between the children's play area and the skatepark has seen a considerable increase in use. This has led to the path becoming somewhat rutted, wet and muddy. The Parks and Estate manager explained that there were two options – tarmacking the path at a cost of around £16,000 – £19,000 depending on the tenders received or resurfacing with stone which would need more maintenance but would have a lower upfront cost.

Members resolved that the path should be resurfaced inhouse using stone at a cost of £2000, funding to come from Earmarked Reserves Open Spaces.

PE/21/069 Boat house and the Lake Pleasure Grounds Centenary Celebrations Members resolved that officers should go ahead with work to prevent deterioration of the Boat House. Funding to come from Earmarked Reserves Open Spaces.

> Members resolved that the next meeting of the Committee would set up a working group that will consider how best to progress the regeneration of the Boat House.

Members resolved that the next meeting of the Committee would set up a working group for planning for the Lake Pleasure Ground Centenary Celebrations.
