The newly elected Mayor, Cllr Robbins read out and signed the Declaration of Acceptance of Office and delivered it to the Town Clerk.

Cllr Robbins was invested with the chain of office by the Town Clerk and returned thanks for his election.

Cllr Robbins read out the following statement.

Thank you members for suggesting and voting for me to be Mayor of Warminster again for the coming year. My first period of office was rather limited due to the pandemic.

I will do my upmost to attend and cover as many of the duties attached to the position and with the support of my Deputy Cllr Keeble and the past Mayor Cllr Jeffries, I am sure we can be hopeful of achieving that goal.

We now have a new team working at WTC and I am sure they will continue to work hard, achieve great things and provide quality services, under our direction, as always.

We councillors are now in midterm and by now fully understanding of the WTC's system of working. We are fortunate to have, as members, very experienced councillors who certainly know their positions, especially whilst attending our sub committees and working groups. I will not defer from seeking their advice from time to time, it is important to listen as well.

Last year we set a reasonable budget with enough finance to administer all the works we set out to complete. We will endeavor to do the same this year. We are now in the process of renewing the Neighbourhood Plan, an important document which will help to shape the future of Warminster. I thank members of that working group, an interesting task. Also, I thank Len Turner for his diligent voluntary work that he continually carries out.

We are now days away from the completion of a major project, namely the Splash Pad in the Lake Pleasure Ground. I would like to thank the staff at WTC for their drive and enthusiasm getting the job done. I'm sure many children will really enjoy this facility as they certainly do the Skate Park.

I acknowledge the fact that the Town needs investment, including new shops, new paint in places and an end to the forgotten buildings. This is a very difficult area as many privately owned and we can only encourage and prompt. We are collecting a general knowledge to ascertain the task ahead. There are some funds available from Wiltshire Council but there are restrictions on areas of spend.

Many of the townsfolk witness me wandering around all the byways, paths, streets with my dog. I spent the morning with Nigel Linge, a great friend of Community, who devotes this time to upgrading and making accessible, all of the above. We hope this will encourage more cycling, walking and running and hopefully more people taking exercise and possibly going to school or work without using a car.

This leads nicely into what I wish to donate the mayor's collection, this year. I hope to help the youth to discover the wider world, not to be in front of a screen. Whether if be cricket, rugby, football, running or even table tennis to join a club etc. We may need to fund training; such is the law and requirements these days. To finish, we certainly live in troubled times, war, increased utility bills and fuel costs which effects every household in Warminster. Let us hope for better times.
