TD/22/007 Public Participation


Residents: Brigette Penny, John Bainbridge, Stuart Yates, and Mr Cunny spoke on the issues they face in both Chapel Street and Bread Street. They detailed examples the corner buildings on entry and exit from the two roads being visibly damaged as the vehicles turn into them, given the tight turns. The residents went on to exemplify heavy goods vehicles entering Chapel Street through the no entry sign from Deverill Road.

Details were given of these heavy goods vehicles being mere millimetres from the cottages' frontage on one side of the road and parked cars on the opposite side. It was felt that this was highly dangerous as this meant that residents could not exit their homes and windows that open outwards had to be kept closed in order that they were not broken off by the large vehicles. One heavy goods vehicle had become stuck in the street which meant that residents had to be contacted and climb in through the boot of their cars, climb over the seats to then reverse their cars out to enable the lorry to have enough room to manoeuvre out of the street.

In all, residents called for improved signage to restrict heavy goods vehicles from both roads.
