PE/22/073	Increased Public Toilet Provision in the Lake Pleasure Grounds In October 2022, the committee resolved to ask officers to bring forward proposals for improving a temporary short-term solution to toilet provision in the Lake Pleasure Grounds for the summer period. (Minute PE/22/036 refers) Members resolved to recommend to Full Council to purchase a 1+1 Double Mains Toilet. The budget of £5,766, including siting works, would be funded from the Ear Marked Reserves Outdoor Services.
