FC/23/001 <u>Election of Chairman of the Council and Town Mayor for the Municipal</u>

Cllr Keeble was duly elected as Chairman of the Council and Town Mayor for

the Municipal Year 2023-24.

FC/23/002 Declaration of Acceptance of Office

The newly elected Mayor, Cllr Keeble read out and signed the Declaration of Acceptance of Office and delivered it to the Town Clerk.



Cllr Keeble was invested with the chain of office by the Town Clerk and returned thanks for his election.

The Mayor of Warminster, Cllr Keeble presented his thanks:

'I thank my fellow Councillors for their support and trust in electing me as Mayor and leader of The Council. It is an honour, and a duty I take seriously and undertake to serve this Council and people of Warminster to the best of my ability. Many of you are far more experienced than me as Councillors and I hope I can count on your help and advice that I will surely need and shall not hesitate to seek.

'I wish to thank the former Mayor, Councillor Chris Robbins for his work as Mayor and representing this town so well. I thank him for his leadership, friendship and advice throughout the last 12 months – it has been a privilege to be your apprentice.

For this coming year I look forward to the completion of the review of our neighbourhood plan. This is an incredibly important document that reflects the public's wishes for the shape and future of Warminster and has already taken a considerable amount of hard work to this point.

'A common theme on engaging with the public on this review is the number of empty shops in the town and the need for local jobs for local people. I therefore wish to focus on the regeneration of the economy of Warminster. As a Council I believe we should all do what we can to support existing and encouraging new local businesses, promoting the shop local ethos and partnering with the newly former Warminster Business Network. We should all be setting an example by buying goods and services locally as much as possible.

'I also want to see renewed effort to develop and finalise our Climate Change Action Plan and drive through the changes required to achieve the Council's carbon net zero target by 2030. I am encouraged that we are currently tendering for solar panels but there is still much work to be done.

'We are now also days away from the completion and opening of two major projects, namely the tennis courts and MUGA refurbishment and CCTV upgrade. I would like to thank the Councillors and Officers of the Council in making these projects happen.

Again, I thank you and look forward to the coming year.'

The retiring Mayor, Cllr Robbins, passed on thanks via the Chairman, for his year in office. He expressed sincere thanks to Deputy Mayor Cllr Keeble for supporting him in his inaugural year. Cllr Robbins also shared how much he enjoyed the year in office, visiting many local businesses and charities having taken the decision to focus on Warminster businesses. He explained that he had refrained from visiting further afield due to Covid. He also expressed his joy of taking part in many of the council activities, including journeying to Flers, in France for the 50th anniversary of the twinning of the two towns.

Cllr Robbins acknowledged that there are always projects, issues or elements within Warminster that the town council try to support, improve or campaign for. The Mayor Cllr Keeble, on behalf of all members, publicly thanked Cllr Robbins for his year in office.

FC/23/008 Chairman's Announcements

FC/22/008.1 The Chairman congratulated Cllr Andrew Davis on his appointment to becoming the Vice Chair of Wiltshire Council. Cllr Davis, expressed that this was great kudos for the town of Warminster and was honoured to represent Warminster Town Council. It has been 25years since the last Warminster Town Councillor had held such a role at Wiltshire Council.

Cllr Keeble announced that both himself and Cllr Robbins will lay a dated brick at the new McCarthy-Stone development in Warminster and attend the opening of the new CCTV Hub and the tennis courts at the Lake Pleasure Grounds.

FC/23/012 Reports from Unitary Authority Members and the Police

Sgt Matthew Roberts, the new Neighbourhood Sergeant for Warminster presented an overview of the priorities for Warminster.

- The priorities from the new Chief Constable for Wiltshire
 - Safer Open Spaces
 - ➤ Local economy patrols checking licenced premises. This will be running throughout Wiltshire.
 - ➤ Violence reduction, for Warminster. Statistics show that this is not a significant issue for the town.
 - Burglary which has shown a significant reduction in the Warminster area over the past year, already.

Sgt Roberts reported that there had been some antisocial behaviour reported in the Lake Pleasure Ground and that a multi-agency approach had been established with suspects dealt with robustly.

Sgt Roberts complemented the upgrade of the CCTV having already made significant impact with the location and apprehension of a suspect and retrieval of stolen items.

There has been a 'knife bin' positioned at Warminster Civic Centre. Sgt Roberts reiterated that Warminster does not have a knife crime issue. This bin has moved around Wiltshire to raise awareness of knife crime.

In conclusion, Sgt Roberts outlined, traffic matters 'Project Zero' – Roads Policing. There have been monthly engagements with 27 traffic related offences. This has shown great community engagement.

Sgt Roberts then answered questions from Councillors.




