#### PC/23/010 **Planning Applications**

PL/2023/02942 Erection of 24 flats. Wiltshire Police, Station Road, Warminster, Wilts, BA12 9BR.

It was resolved that there was objection to the application with the following comments:

- Access is insufficient to and from the development as it is on the corner of the junction.
- The mass and volume of the development is too large and would be dominant in the area.
- The heritage and archaeological survey are not up to date.

Reserved matters application pursuant to 19/07198/VAR relating to appearance, landscaping and scale in respect of Zones A, B, Ea and Eb, seeking approval for medical centre and pharmacy, 46 extra care apartments (Class C2), 39 extra care apartments (Class C2), 6 retirement bungalows/chalet bungalows (Class C3) with associated access roads, parking and infrastructure. Zones A, B, Ea and Eb, Land North of Grovelands Way, Warminster, BA12 8TB

It was resolved that there was no objection to the application.

PL/2021/09013

Outline planning consent - some matters reserved. Erection of up to 205 no. dwellings, community hub, public open space, access, infrastructure, and associated works, with all other matters reserved. Land West of Westbury Road, Land West of Westbury Road, Warminster.

It was resolved that members wished to add further comment to this application:

- There has been a removal of the community amenity spaces.
- Although indicative drawings are contained within the Phosphorus Neutrality Report, there are no revised plans submitted e.g. Design Access Statement or Illustrative Masterplan, to show the proposed layout of the water treatment facilities and removal of the amenity spaces.
- There are significant concerns over the potential health hazards associated with the reedbeds such as Leptospirosis and the safety risks associated with the ponds, especially for children.
- There is no information regarding life expectancy of the Reed Beds, the ongoing maintenance costs in perpetuity and who would be responsible.
