Advisory Committee for 2023-24.


HC/23/002 Election of Committee Vice Chairman 2023-2024

HC/23/009 Minutes of the LHFIG

The minutes of the LHFIG meeting held 10th May 2023 and the LHFIG Terms of Reference and Guidance notes were **NOTED**

HC/23/010 Traffic Survey Results - Westbury Road, Warminster

The results of the traffic survey on Westbury Road was **NOTED**. The average speed was 31.3mph with 85% of traffic under 35.6mph. In a 30mph zone, 15% of traffic has to be at speeds of be between 31.5 and 41.9mph for community speed watch to be considered and 15% of traffic has to be at over 42 mph for Police Enforcement to be considered.

Members requested that the survey results were forwarded to the police for their information.

HC/23/011 Highway Improvement Form Requests

HC/23/011.1 Bradley Road - Request for Traffic Calming

Members Noted a request for a traffic survey in Bradley Road had been submitted to Wiltshire Council in June 2023. Any further action would therefore have to await the results of the traffic survey. Members asked that the member of the public be advised of this and the concern about speeding traffic was passed to the police.

HC/23/012 Waiting Restriction Requests

HC/23/012.1 Request for double yellow Lines on Weymouth Street
Members resolved not to support the request for double yellow lines on
Weymouth Street. They requested the Town Clerk write to the resident to
advise that the request would not be supported as the installation of yellow
lines can just move problems in other areas and the roadside parking can
help reduce traffic speeds. Additionally, the problems in Weymouth Street





are only at certain peak times whereas the effect yellow lines would be all year round.

HC/23/013 Other issues

HC/23/013.1 Silver Street

A request had been made for various measures aimed at reducing traffic speeds. Members noted that the matter had only recently been considered by the Council and that nothing had substantially changed since then. Members resolved that no further action would be taken.

HC/23/013.2 Residents' Only Parking Emwell Street Members resolved that the resident be contacted and advised that the problem of people dropping off children at school and collecting children from school would not be affected by residents parking.

There are a few resident parking schemes in Wiltshire and they have both pros and cons, details can be found on the Wiltshire Council website.

HC/23/013.3 Parking problem in Copheap Lane Members were advised by Cllr Parks that the issue was now in hand. Members resolved that no further action be taken regarding the parking problem in Copheap Lane,

HC/23/014 Appointment of Community Speed watch Champion

Members noted that three Community Speedwatch Champions had been appointed in recent years and none had generated enough volunteer to launch a viable scheme.

Members resolved not to appoint a Community Speed Watch Champion.
