FC/23/063 Apologies for Absence


Apologies of absence were received and accepted from Cllr Fryer and Cllr Syme.

FC/23/064 <u>Declarations of Interest</u>

Cllr Brett declared a non-pecuniary interest in agenda item 11, as a patron of Sustainable Warminster.

Cllr Jones declared a non-pecuniary interest in agenda item 11, as an attendee at meetings of Sustainable Warminster.

FC/23/065 Minutes

FC/23/065.1 The minutes of the meeting held on Monday 24th July 2023, were approved as a true record, and signed by the Chairman.

FC/23/065.2 There were no matters arising from the minutes of the meeting held on Monday 24th July 2023.

FC/23/066 Chairman's Announcements

FC/23/066.1 The Town Mayor, Cllr Keeble, advised members about the very successful twinning visit by a delegation from Warminster, Pennsylvania, noting that both towns were keen to strengthen links between them.

FC/23/066.2 The Mayor's engagements were noted.

FC/23/067 Correspondence Circulated

FC/23/068 Questions

There were no questions submitted in advance by members of the council.

Standing Orders were suspended for public participation at 7.04pm.

FC/23/069 Public Participation

Cllr Tony Jackson, Unitary Councillor, Mr Michael Turner, and Mr Chris Roberts spoke to agenda item 12, requesting that Warminster Town Council lobby Wiltshire Council to reopen the second squash court at the Leisure Centre, emphasising the health benefits of playing squash and the need for two courts for team events.

Cllr Tony Jackson, Unitary Councillor, Mr Iain Perkins, and Mrs Harriet James spoke to agenda item 11, requesting that Smallbrook Road be closed both day and night from just beyond the nature reserve car park to Turnpike Cottage each year from 14 February for one month to protect the toads as they migrated to their natal pond to breed.

Mr Steve Bond spoke to agenda item 14 explaining that, in his opinion, the land at Folly Lane should not be designated as a Local Green Space in the Neighbourhood Plan.


Standing Orders were reinstated at 7.25pm.

FC/23/070 Reports from Unitary Authority Members and the Police

Cllr Davis informed members that Wiltshire Council's Local Plan was now out for consultation.

Acting Sergeant Tom Newman detailed:

- The actions taken to tackle anti-social behaviour in the Park.
- E scooters remain an issue; legally, they are not allowed in the public domain, only on private land.
- Multiple arrests have been made for shoplifting, but not all of these have led to convictions.



FC/23/071 External Audit

Members noted the External Auditor's Report and approved the Notice of Conclusion of Audit Dates for publication.

FC/23/073 Possibility of overnight road closure of Smallbrook Road during the toad migration season

Members resolved to ask officers to undertake further works, including carrying out an informal consultation with residents and local businesses, in order to understand local opinion, estimated costs and strategies, and to work with Wiltshire Council to pursue a possible temporary road closure from 14th February to 13th March 2025 and annually thereafter.

FC/23/074 Squash Courts at the Sports Centre

Members resolved to approach Wiltshire Council requesting the reopening of a second squash court at the leisure centre.

FC/23/075 Councillor Laptops

Members resolved that the provision of Council laptops would be phased out by the end of December 2023. Councillors would access and store their council emails and documents by logging into a cloud-based system on their own personal devices. The council would retain one laptop for use by Councillors in the Civic Centre.

FC/23/076 <u>Warminster Neighbourhood Plan Update</u>

Members noted the update about progress to date on the new Neighbourhood Plan.

FC/23/077 Wiltshire Local Plan Consultation

Members resolved to approve the response to the consultation.

FC/23/078 Warminster Rugby Club Floodlights

Members noted the update.

FC/23/079 Warminster Town Council Civic Awards 2023

Members noted the addition of an Environmental Award for businesses to recognise their contribution towards tackling climate change and working towards net zero, and that nominations for the 2023 Civic Awards were now open.

FC/23/080 Warminster Community Centre

Members resolved to purchase a defibrillator for installation by Warminster Community Centre at their premises in Warminster Town Park.

Ongoing maintenance costs would be met by the Community Centre.
