FC/23/093 Lake Edging Report

Members resolved to approve the quotation of £3,925 plus VAT from Wiltshire Wildlife Trust to work with officers to develop costed designs for replacing the sheet piling around the lake with a more natural, biodiversity rich, alternative and to take the funding from Earmarked Reserves Services to be Devolved.

FC/23/094 Town Centre Street Furniture

Members resolved to proceed with the redecoration of 16 finger signposts, 17 hanging basket posts and five CCTV posts at a total cost £14,167.88 plus VAT, £5,773.08 to be funded from the Wiltshire Towns Programme and the remainder from General Reserves.

FC/23/095 Vintage Gas Lamps

Members resolved to approve the adoption of five vintage 'gas' lamps from Wiltshire Council.

FC/23/096 Climate Strategy Action Plan

Members resolved to approve the council's Climate Strategy Action Plan for 2024 to 2029 and to amend the terms of reference of the Climate Change Working Group to "assist in the promotion and implementation of the Climate Strategy Action Plan and provide an update each year on progress made."

This is a working document which can be amended, all the comments made during the public participation can be discussed at future meetings.
