MINUTES OF THE MEETING

Item 1. Apologies: Cllr Kirkwood, J. Abbot, J. Ellison

<u>Item 2. Electrician major works discussion:</u> Since last meeting quote received, and recorded in July minutes, is now void, items no longer available a that price.

- Committee discussed requirements with electrician to include security cameras (4 of in total) mounted on short poles (2 of in total) to the Pavilion gable ends; and 3x PIR security lights fitted to Southside of Pavilion at eaves height. Proposed by JH, ALL AGREED.
- Camera operation at this time to be restricted to night, or hours of darkness during winter months.
- Installing cameras on pole was not originally quoted for, but the Pavilion eaves are below 8ft and as such easily accessible on foot and susceptible to vandalism.
- Hardwired cameras to be used as no site Wifi; connecting the allotment site to wifi is
 possible and not cost prohibitive, however, monthly ongoing costs would eventually
 exceed the cost of a hardwired option and would need a nominated person for bills
 etc.
- Committee discussed possibility of using cameras to cover allotment plots. Electrician confirmed cameras would be setoff by animals at night and moving vegetation, it would be impractical, committee agreed camera coverage would be restricted to Pavilion curtilage with possibly coverage of carpark on northside.
- Existing PIR security lights are fit for purpose and do not need replacing.
- Committee agreed work needed completing before the end of October to avoid serious inclement weather due to working at height, preferably before the next AGM.
- Electrician confirmed that as the work now required working at height additional help would be required, this had not been included in the previous quote.
- Committee agreed a requote was required and a final decision would then be made.

Electrician left the meeting at 2000.

<u>Item 3. Minutes from Last meeting (17/07/2024):</u> No comments or amendments Committee agreed minutes, verified by Chairman.

Item 4. Matters Arising: NIL.

<u>Item 5. Treasurers Report:</u> July 2024, Month 4 of 12 in the financial year. **Total** income £352.74, Total expenditure £334, surplus of £18.74.

Income included: rents £68.60, Hall donations £169, bacon butty mornings £100, tea & coffee £15.14. **Expenditures:** Pavilion cleaning £80, maintenance £254.

Cash position for the year to date (31/07/2024) – Total cash £20,347.21, comprised of Community Account £5,848.09, Premium Account £13,226.35, and cashbox £1,272.77. Net Assets £18,847.21 (includes £1,500 accrual for double doors, bill not paid yet due to outstanding work).

- Concreting of the access ramp to commence in the following week.

Environment Agency

- It has been a dry period so not a lot to update from last report. Started property flood resilience at Shrewton. Properties have been surveyed and contractors will be out in the next couple of weeks.
- Flooding resilience entails looking at any community to see if there are any options for flood alleviation schemes on a community wide scale, if that isn't

possible then look at individual properties. Measures depend on type of flooding and type of building etc. Could be flood doors, pumps etc.

Wiltshire Council

- More money than previous years.
- This means more equipment and more staff. Previous member of staff Richard Williams is back and currently looking at schemes.
- Going out to town and parish councils to see if they have any quick wins.
- 3 Teams of CCTV running. Historically generally have one team operating.
- Drainage and maintenance have been given money to resurface and improve roads and structures. Before a road is resurfaced the drainage is checked for condition and if necessary, works undertaken before resurfacing. This also enables us to undertake reclaims against utilities if they have damaged or broken our assets. We have 7 years to reclaim from those companies.
- More repairs gangs going out doing works. Additional gully tankers and Vactors. Trying to get on top of a historic maintenance back log.
- This is the first year we are more than 6 weeks ahead of the major maintenance programme due to more resources.
- We have also been out to town and parish councils affected by flooding from Henk and Babette E.g. Teffont, West Deane.
- Town and Parishes can apply to drainage for small schemes.
- Nic advised from a portfolio perspective, there is more money available due to the flooding over the last year/18 months due to major flooding events. This has highlighted areas where there need to be improvements and money needs to be spent. It also means more opportunity for town and parishes to come to the OFWG meetings to represent their groups with suggested areas needing improvement and schemes that could be implemented. Please encourage your neighbouring parishes to come to this meeting particularly as some issues and solutions are cross border. The meeting is also an opportunity to understand the issues others are facing as well as your own.

Wessex Water

- Nothing major to update on.
- Danny requested a list of areas being worked on for schemes and investigations. That will take some time to compile Charlotte will try and pull something together.

Thames Water

 No representation at the meeting. However, if anyone has questions we can forward them on to TW

Presentation from Naomi Styles, Wiltshire Council GAPS Team

(Grant Applications and Planting Support)

Supporting the Delivery of Nature-Based Flood Mitigation Schemes

 The presentation will be repeated at the Northern Operational Flood Working Group.

- These are government grants that Wiltshire council distribute. England woodland creation within the last 10 years.
- Naomi advised every site was dealt with on an individual basis. The scheme is not confined to rural areas and can involve urban areas in towns and parishes.
- They work with Forestry commission, land agents and NFU to communicate their work to farmers and landowners, town and parish councils, large and small. Difficult decision for farmers to make and they can be reluctant to make these decisions. Parish and Town councils are a good outlet for helping to get the message out there.
- The payments can be quite generous depending on the proposal and covers both small and larger scale schemes.
- If there is planting over half a hectare it must go through environment impact assessment (high level study) involving statutory agencies including Environment Agency, Natural England etc. Detailed assessment looking at water, wildlife, archaeology, history, landscape etc.
- If works are being carried out to reduce flooding by statutory agencies including Wiltshire Council, there are opportunities for town and parishes to build on to those mitigation works being carried out.

Parish Reports

Upper Deverell's

- Since last meeting we have established flood groups in each of the villages.
 Notices have gone out to parishes. Important to record the information with a
 photo, the location and date, put on MyWilts and let Parish council know. The
 parish would also like to know what work is going on in their parish. Atkins
 who provides the service publish this.
- Kingston Deverill advised the riverbank has eroded. A coordinated approach
 is needed as it could be caused by multiple factors and several agencies may
 need to be involved.
- A meeting needs to be organised inviting the relevant people to coordinate the work.

Salisbury Cathedral

- Waiting for the report to come out from the recent survey.
- Danny fed back to Mike that some of the properties got flooded but didn't apply for funding. It is believed this is in hand now.

Pitton

- Danny is available to attend the key stakeholders meeting 2nd September, 4pm.
- Membership of flood action group in the village. One member retired and another member is no longer a member. Queries to Wiltshire should be from current group members only, not from individuals.
- Request for drain near syphon. Any ideas or plans can be sent to Danny and assessed before the meeting on 2nd September.

Wilton

- Many of the gullies in the town are full of compacted silt. A lot of these were Vactored in January/February.
- A lot of CCTV work that has happened for Shaftesbury Road but at the bottom
 of it, the highways drainage goes into St Johns Court and back under the A30
 and into the Wylye channel. Concern the new surfacing will back it up on the
 Shaftesbury Road. This is with Danny and a colleague in Highways.
- Churchill court this is with Atkins. Danny will chase.
- Drainage maps have been sent to Wilton previously.
- Concern that the parish can't get enough gullies emptied before flood season.
- Main roads will be done on annual basis. Some of those roads are national highways so for information about the clearing for these, go straight to National Highways.
- If the discretionary gully service request doesn't happen, what happens to it?

Pewsey

- Paul Cobbins introduced Peter Sharpe, Chair of the flood working group in Pewsey. They had flood plan but was 10 years out of date. The plan was rewritten the day after they were flooded.
- The group has been formed and they have several ongoing tasks:
 - o Contact all households at risk and provide info pack.
 - Putting together a note for all landowners that have bank to the river, so they are aware of their responsibilities.
 - Built up a list of measures that case is being built for. Once there is a plan they will approach relevant agencies. That should start in about a months' time.
- Village is taking it seriously and mentioned the drop-in day was very useful.
- Environment Agency queried how the Parish had come up with the list of people at risk. Parish has done work in the past. Number is up to about 60 houses. They have looked at Environment Agency flood risk mapping. Some questions about some other areas but have been able to determine houses that flooded and those that are risk into high risk and medium risk categories.

Warminster

Had meeting recently and another scheduled after the next flood working group.

East Kennet

- Significant road flooding problem. High traffic and very tourist area with lots of walkers.
- Parish is being proactive. Had a JCB for a day and dug 60m of deep ditches to link the road to the river.
- Would like a bit of help from Wiltshire on some other areas and invite someone from the team to come out for a meeting.

Teffont

• Scoping phase one with major improvements at top of the village and instructing an environmental survey. Need to do environmental impact study

- and seek landowner approval to do the works. Once these are in line then the scheme can move to the next stage.
- Job request was made for the drains to be cleaned around the bridge area.

Laverstock and Ford

- Nothing to report.
- Difficult to know if the small scheme of works at Milford Mill Road is working as the weather is dry now.

Britford

- Parish still planning to build a bund to prevent flood water.
- Query about storm Henk money Because of the volume of flooding across the country there is a shortage of surveyors available to do the work.
- Wiltshire has instructed Atkins to get a group of surveyors to do the surveys.
 Emma will be sending out an email to everybody who applied for funding with an update.
- Environment Agency confirmed there are 89 properties were flooded which would save the need for a further survey. Need to investigate if the EA survey is adequate.
- The question was asked if the grant money could be used for a community funded project. DELTA advised they can take money for individual projects and put it into one pot.
- PFR surveys should be completed by September.
- Drainage project on Church Lane. Parish is getting a survey done and will come with a costing and plan in the next few weeks.

Redlynch and Landford

- Thanks to the drainage team for help at Beech Grange.
- Drainage team have confirmed the issues around Pound Hill and Glebe Lane are suitable sites for drainage work as part of a capital scheme. Looking for an indication as to what year this might take place.
- Danny confirmed it is on the list but because of location it needs a road closure, these take 3 months.

Great Bedwyn

- Reported that the parish have had some gully clearing. Unsure about which
 ones had been cleared. This was covered earlier in the meeting. It is hoped
 details will be publicised in future so parish councils can report it to
 communities.
- Church Meadow had a long dialogue with agents for the crown estate who
 own the land where the outfalls arrive at. The issues have been about getting
 the ditches cleaned beyond those outfalls as they are significantly blocked.
 The agents believe it is the council's job to do it.
- Danny confirmed it is not possible to serve notice on Crown Land.
- Brook street Presented a report to Danny and Highways engineer. Had good buy-in from the major landowner who look as though they are going to create flood storage and soakaways which would help around Jockey Green

- area. At the outfall end there is still a challenge of getting the syphon cleaned and the ditch dug out.
- The land is in the process of changing ownership and that will dramatically change the ability to get access as the current owner has not been cooperative.
- Parish is looking for help with smaller schemes and would be grateful for the council's view on these e.g., creating new grips off the highway onto the land to help alleviate the flooding. Would like guidance on where the council sits about responsibility and is it appropriate for the highway. Can a landowner go ahead and dig a ditch on their land.
- Yes, as it is their land, but would be beneficial if it was in consultation with the council, adjacent landowners to manage the water better. A landowner would need a section 50 license from WC to do any work on the highway.

Aldbourne

- Had meeting with Wiltshire Council, Thames Water, Environment Agency in June. Action points were established with flood warden group and the parish council are ongoing.
- Reminder to Danny about issues around Lottage Road and progress on that.

Westbury

- Very few flooding issues reported to Town Council. Are there issues that are reported to Wiltshire Council that they are not aware of?
- Danny summarised various areas where flooding happens including several internal property issues and the railway bridge on the A350.

Warminster

- Andrew Davis updated about a large water storage facility currently under construction until March 2025 in Warminster.
- Charlotte Fry confirmed the work is part of the Environment Agency delivery programme to deliver 13 improvements to storm overflows in the region that frequently overflow. This should reduce the spill frequency from the overflow in Weymouth Street.

Carrie Whittaker

- Modelling project going on in Tisbury going on steadily.
- Community event planned end of September in Wilton
- Salisbury scheme spoke to scheme manager. Other than planted should be completed by end of September.

Micheal Holm – Environment Agency

Continually wet months up to June including Storm events. The Agency are trying to service the needs of all the communities. Over 100 were affected and a similar number in Somerset. They recognise how urgent the need is but ask for patience for responses to emails and requests for meetings. The EA are planning on running flood drop in engagement events in July.

Michael confirmed that no literature has been sent out yet.

Sven Hocking (Salisbury) Cathedral close meeting aiming for 10th July should hopefully confirm today or tomorrow.

Wessex Water - Charlotte Fry

Nothing to report.

Thames Water - Denise Kinsella

- In a similar position to the Environment Agency. An extremely wet winter so teams have been busy, supporting different parishes across the whole of the Thames valley.
- Beginning to attend local meetings where invited and possible.

Wiltshire Council

- Danny Everett reiterated the struggles faced by both the statutory agencies present and gave a brief overview.
- There have been:
 - o 21 storms
 - Over 300 internal property floods
 - o 100 communities affected

- Part of the response to this from the Council is to put on more resources e.g., more CCTV units to get ahead of the programme of work.
- There is an Extra £1million to do carry out drainage works, and they are adding more resources via the contractor Milestone.
- A minimum of 50 properties have flooded internally within the County during an event, at which point the grant scheme funding becomes available. In Storm Babet 100 flooded and with Storm Hank we in excess of 200 homes flooded.
- There is a serious shortage of surveyors. The Council are working with Atkins to source them. Dates not available for when they can start work but they are being trained.

Parish Reports

Kennet Valley Parish Council

Jill Turner

 Sewage flooding into a garage and extensive road water flooding. Developed some actions from meeting in May. Waiting on outcome from recent Thames Water camera work as well as updates from Wiltshire Council.

West Amesbury

Robert Yuill

- Perennial issue is flooding of roundabout at Countess roundabout, which is a National Highways issue.
- A lot of the estates have SuDS installed (Sustainable urban Drainage Systems). The Parish expressed concern that the roads are defined as private highways which won't be adopted because of SuDS.
- It was confirmed that the roads may be adopted, but the drainage assets off
 the highway won't be. They will be managed by a company funded by
 residents. Any issues would need to be addressed by the management
 company. As part of the planning application for the SuDS, they must assess
 how much it will cost to maintain.
- They also noted that the Parish have settlement ponds, and some never get any water. They are there for extreme events. If there is no water after a large storm then please take photos and then report to Wiltshire Council.

Pewsey

Paul Cobbins

- Currently looking at addressing the various flooding issues around Pewsey.
- Collecting information and drawing up a flood plan.

Laverstock and Ford

Jon Gunns

- Flooding happens every year in Ford and involves private land. The aim is to organise a meeting with those affected to understand how it is happening. Potential issue is part of the land is SSSI. Hoping to get that going soon.
- River Bourne goes through Ford, flooding around the bridge.
- It was noted that the Parish should actively engage with Natural England and Environment Agency regarding the SSSI as there is a process that needs to be followed.

Rushall

Colin Gale

- Drains cleared on 19th June leading into Rushall bridge. There are two drains, that still need attention.
- One side feed directly into river, the other falls to a property and relies on a
 ditch to get the flow going. It was confirmed that it is the land-owners
 responsibility to clear the ditch on their land regardless of whether it is a
 garden, field, access land etc. That is under riparian responsibilities.
- Waiting for the ditch in Church Lane to be cleared. Takes water from the A342.
- Colin to contact Danny after the meeting to determine what interest Highways have with the ditch.

Britford

Derek Finnis

- Britford flood defences trying to get consent to build resident funded bund.
- Keen to get some works started this year. Looking for support from Wiltshire Council, Natural England, and the Environment Agency.
- The hope is that part of the funding for the bund would be reimbursed.

Newton Tony

Chris Andrews

- The Bourne in Newton Tony another winter of record rainfall but no residential flooding. The last major flooding event was in 2002-2003 and after that various mitigation measures were taken. Properties along the Bourne are still being flagged as high flood risk by insurance companies – it is either very expensive if not impossible to insure against flood risk at all and this also can be a big issue when trying to sell a property.
- Is it possible to have the flood risk downgraded?
- Mapping of risk is done to show possible risk of flooding and should not be used to property level. New maps (Nafra2) are due to be released next year which could results in some properties moving in or out of risk areas.
- Contact National Flood Forum https://www.floodre.co.uk/ which was set up by the government and insurance companies to provide affordable insurance to those affected by flooding. The property must have been built prior to 1st January 2009.

Pitton

Chris Sankey

- The Winterbourne ceased running on 9 May, and the Southern Water emergency tankering operation ended during the last two weeks in May.
- The Dunstable Road was opened on 25 May, but some road repairs are outstanding, particularly along road edges.
- The Parish received a warning from the Environment Agency that groundwater levels are above normal for the time of year, making it more probable that flooding is likely to be a problem this coming winter.
- Danny confirmed that no progress has been made to providing a date for the
 meeting of key stakeholders to look at options for flood alleviation in the
 village. He has had trouble getting a response from the Environment Agency,
 Mike Holm will check with EA Romsey. The Parish Council will also write to
 the Environment Agency, Romsey to ask for their agreement to take part in a
 stakeholder meeting. They will also write to Southern Water because the
 sewage infrastructure had a serious failure.

Coombe Bisset

Parish Clerk

Keen to meet to progress works already discussed for Homington Road.
 Some resurfacing works planned and CCTV of drainage system, will be carried out before this is done. Wiltshire Council will be in touch as soon as possible.

Sutton Veny

Nick Barton

- Long Streer/High Street going down a 30 angle. Every year Duck Street is flooded, exacerbated because 13 drains on High Street are still blocked. It is a perennial problem and get blocked regularly. A recent survey indicates that some haven't been cleared for more than a year.
- David Button reminded the Parish that Lee Haines is the Engineer for the community and that defects need to be recorded on the MyWilts app.
- The Parish confirmed they have been recorded and talks have already happened.

Redlynch and Landford

Zoe Clewer

- Doing some CCTV work at Glebe land and Pound Hill coming out of new £1million funding. Hoping to get a meeting about Beech Grange.
- Would like to get a date for a meeting to look at Lyburn Road where an extra culvert is needed.
- Thank you for ditching work going on New Road.
- Discretionary gully service is working well in Redlynch.

Whiteparish

Parish Clerk

Nothing to report.

West Deane

Jane Higgins

 Thank you for the discretionary gully clearing. Cllr Britton is working on flood mitigation work from the £1million fund. Looking forward to progress.

Tidworth

Carole Webb

- Flooding in January with 10 properties seriously affected. They believe the reason for some of the flooding was due to weight from vehicles travelling along the highway and bow-waves but may have also been gully clearing issues.
- 6 residents have made a claim for compensation under Storm Henk. They
 have made a complaint about closing roads and the last correspondence
 received was 6th June.
- Emma Biggs reiterated that the council is still waiting for surveyors, but confirmed that if residents have received an email, then they are on the list for surveyors.
- Cluster groups have been put together for the surveyors based on the applications received. If they received the email, they are part of a cluster group.
- Discretionary gully clearing is administered by the Local Highways sewer team – this is a Wiltshire Council resource not outsourced.
- The clearing was postponed from January until May. There is a 30-mph limit on A338 and were informed it would only be eligible for clearing every 3 years.
- David Button confirmed that gullies are emptied on a schedule depending on what type of road they are. If they are high risk, they can be emptied more regularly – e.g., added to high-risk register.
- Flood Warden has resigned but in process of appointing another.

Netheravon Parish Council

Nothing to report

Teffont

- Difficulty in obtaining funding for their scheme and it is not making any progress. Danny advised Wiltshire Council has Highway Authority and Land Drainage authority to discharge water off the highway. To do this we need landowner permission, which only needs an email confirming permission. If the landowner refuses, we can use Section 100 of the Highways Act. We cannot do it without permission otherwise the authority will be open for litigation.
- We can only use Section 100 in an emergency to cut additional grips.

- Meeting needs to be arranged with the Highway Engineer to sort of the consents needed.
- As it is a sensitive area as SSSI, EA and Land Drainage consent may be needed.
- Request to be put on list for funding.

Kilmington

Graham Cotton

- There has been minimal or no residential flooding.
- The River Wylye rises in Kilmington and flows through village. At the lower end of the street there is a collection point with two exits points which take the water under the B3092 and then goes underground.
- Those pipes/culverts are blocked. The water overflowed into the road and weakened the bank. The concern is if the weather over winter is bad again then the bank could collapse. This would result in the road needing to be closed which would be devastating for the village.

Kilmington request:

- 1. Arrange CCTV survey to establish location and extent of blockages
- 2. Plan action to remove blockages.
- It is an issue that Wiltshire Council are aware of and is on the list for inspection. David Button noted that the CCTV crew is at Kilmington today (26th June) working on the soakaways and suggested that they could potentially go and survey the pipes today or tomorrow (26/27 June). He also confirmed the seriousness of the issue should the Pond elevated above the road collapse and that the pipes are not flowing with the capacity flow that they were designed to have.

Longbridge Deverill

Caroline Sawyer

 Reoccurring issue with landowner who isn't doing the work they should be doing to mitigate the cause of flooding events. The main issue is that it floods the sewage system.

Tilshead

Victoria Burbage

- Flash flooding event which flooded 3 out of the 10 that usually flood. They
 would like to coordinate with the MOD. Danny Everett has good contacts with
 the MOD. Parish to email with details
- The issue has been reported several times. ACTION: Wessex Water will check with operations for any reports received.

Wilton

Alan Crossley

- The flood barrier was dismantled on 8th June in Crow Lane. The ditch has stopped flowing so silt levels can be addressed properly. The ditch contains vegetation is working its way into a culvert. Flood group members are continuing to report via MyWilts. Some have been referred to discretionary gully clearing. They are awaiting a response from Atkins.
- Alan also expressed that they want to make more progress on mapping the drainage.
- David Button clarified the process for the placement of ditch diggings and outlined that it is standard policy to take risings from ditch diggings onto the verge. There are two main reasons for this – 1 the ecological benefit and 2 – the cost. Where there is no verge Wiltshire Council will aim to take them away, but the costs are very significant. The samples then need to the tested in a lab before removal to another location.
- ACTION: David Button will follow up.
- He also noted that on every occasion it has been dug out. The Vactor has
 gone through to blow through the discharge pipes going into ditch. The main
 Issue with the ditch is that it discharges via a culvert and away into private
 land then into the river. Maintenance is required on the land to get a better
 flow to the river. It was agreed that these works would be put into the hands of
 the local community. The ditch will always struggle without undertaking these
 works.

Upper Deverills

Belinda Stewart-Cox

- Proposed the development of an Upper Deverills community flood working group formed of key local stakeholders to improve coordination and communication among residents, local authorities, and conservation groups for better flood preparedness and response.
- Currently, residents are reporting issues, and the local council aren't always aware of them.
- Reported that a local farmer has been very helpful digging ditches.

Marlborough

Richard Spencer-Williams

- Richard from Marlborough reported the community's involvement in flood planning, including the review of the flood plan, a community partnership meeting with statutory agencies and Wiltshire Council and the training of new flood wardens since the flood event in January. There is also a planned workshop day in October to involve the community in helping to develop practical solutions and preparedness for residents. The flood plan is now synced with an alert system.
- Had a big picture partnership meeting with statutory bodies and local authorities. Received very well by the community. New flood wardens doing

- training to help firm up aspects of flood plan which is synced with alert system.
- Richard highlighted the need for clear protocols regarding road closures during flooding events including coordination between the policy and Wiltshire Council. He mentioned efforts to clarify responsibilities and procedures with local authorities and the police to prevent future flood damage.

David Button (Wiltshire Council - Local Highways Engineer)

Highways departmental responsibilities

- It is important to remember that although Highways is referred to as overseeing the road network, there are different parts of the service. Local Highways are responsible for maintaining what is there, not improvements or new works.
- For new works requests for support and funding can go through the LHFIG process (<u>Local highway and footway improvement groups</u>) or the local area board.
- Typically, parishes are asked to contribute 25%. They can pay for the entirety
 of work as long as they have the necessary consents for carriageway and/or
 verge and the work is carried out by an approved Highways accredited
 contractor in in accordance with The New Roads and Street Works Act.
- **Discretionary gully emptying service** could benefit Sutton Veny and Tidworth.
- Whilst this service can help many, it is only suitable for work on quieter, lower speed areas. It is not able to operate on high-speed roads as there is no Traffic Management gang or resource with them. Nor can they operate on roundabouts or sharp junctions.
- They can't do jetting. When this is needed, a local tanker including the Vactor tanker can be scheduled.

Local highways and drainage maintenance update

- David reported that they have just completed 2 weeks' worth of ditching operations completing many jobs. They are waiting for final list of what has been completed.
- The ditching resource returns on 22nd July. David will then establish with engineers what of the existing requests are still outstanding before looking at newer reports.
- Subcontractors have changed and the frequency of provision has improved from every 5 weeks to every 3 weeks. More powerful Vactor resource.

Statutory Updates

Micheal Holm - Environment Agency

This winter has been the wettest on record for 150 years. With 200% of long-term average rainfall recorded in March. River levels and groundwater levels remain high. We have had a few days of dry weather, but things remain unsettled.

Chris Wood - Dorset and Wilts Fire and Rescue

Following the flooding of Ashley Road, Dorset and Wiltshire Fire and Rescue would like to be involved in the OFWG to offer reassurance and have a better overview. Only call 999 in a 'risk to life' situation such as cars stuck in flood waters or residents



trapped in their homes by flood waters. They have some water rescue elements but not sandbags, cannot assist in general flooding situations; only where lives are at risk.

Parish Reports

Semley

Danny said we are awaiting new engineer starting in June to address the issues in Station Road.

Berwick St James

James Hardy

Lots of ground water. With the A36 Stowford junction is heavily waterlogged. Still groundwater pumping from main drains in centre of the village. Working on flooded sewerage system in the Girl Guide hut.

Aldbourne

Jim Oliver & Nick Josephy

Still has flooding, water rising in several places along Lottage Road. Still has Thames Water mobile sewage treatment plant in the village taking and treating surface water from the sewers and putting it into the river Bourne. However, this has been unreliable and when it breaks down sewerage comes through the manhole covers. Groundwater at 143.6cm needs to fall 2.0m before they have falling groundwater. Requested gully and culvert clearance in Lottage Road as the drainage is not working correctly. Have been visited by Parish Steward and road sweeper but needs a visit from gully tanker. Requested a meeting with Wiltshire Council, Thames Water, and the Environment Agency before next Autumn to look at solutions to avoid the mobile sewerage unit being deployed in the village.

Wilton

Alan Crossley

River Wyle level has dropped, and Wilton Flood Volunteers hope to dismantle the Crow Lane flood barrier currently in place after consultation with EA. Ongoing issues with high ground water levels causing springs in Water Ditchhampton.

Wilton Flood Volunteers continue to report reported silted up drains on My Wilts app and the discretionary gully tanker is booked to attend. Thanks to the Parish Steward for ongoing engagement. Non return valves need to be fitted to the outfalls in Churchill Court over the summer. Requested more progress on mapping the Wilton drainage system. KaarbonTech are currently undertaking the contract to map Wiltshire's drainage system assets. Danny to investigate if we can supply a mapping system to town and parish councils who wish to map their drainage system.



Pitton and Farley

Chris Sankey

Flood Action Group submitted a report from the Flood Group to Wiltshire Council yesterday. The Winterbourne is flowing strongly. Thanks to the EA for the cameras to monitor the river levels and flow. No internal property flooding in Pitton this winter but one in Farley in November 2023. Some road and land flooding. Requested a meeting with Environment Agency and Wiltshire Council in the summer.

Hindon

Charlie Brooker

Enquired regarding grants to improve the flow of the River Dean?

Directed to enquire via the parish council for LHFIG monies. Concerns regarding the algae in the River Dean in areas of slow-moving water. Report this to the EA 24-hour incident hotline (0800 80 70 60). Believes it comes from farm run off. Three properties prone to septic tank flooding with discharge to the Dean; the main sewer is around 200m away, would it be possible to join the main sewer?

Danny: <u>First Time Sewerage</u> on the Wessex Water website. If there are enough properties in the village wanting to go onto the sewerage system, it may be possible to add a connecting sewer however residents would be responsible for connecting their individual properties.

Micheal H – in chat I have supplied a FAQ of how to get properties connected to water and sewerage systems.

Rushall

Colin Gale

Further flooding on Good Friday. Road by the bridge heavily flooded. Avon Villa garage flooded again. Drains adjacent to Rushall Bridge need clearing. Flood warden has dug out the ditch by Avon Villa, but it needs blasting with the discretionary tanker. Has already been reported 4 times on MyWilts. The local highways engineer has said this is not a priority.

Enford

Richard Roberts

Ground water is still springing up, extensive flooding in the centre of the village with effluent. Concerns over health hazard for those walking through sewerage especially as it is on the route to school bus. Drains need to be unblocked. 5 properties suffering internal flooding; one still uninhabitable. Wessex Water has a pumping station in the village. The springs have created large potholes.



The 5 to 6 drains are completely overwhelmed with silted water from Salisbury Plain, needs an engineering solution. Possibly more drains and the existing drains flushed. Parish Steward has been in attendance for potholes.

Graham Axtel noted the Vactor/Gully Tankers have some available time as does the Discretionary Tanker. They are on a rotating basis and are in the area on a three-week rota. Book via your Parish Council.

Teffont

EA and Drainage Team have submitted a report this week to Teffont PC to support chasing local landowners to undertake land management to mitigate flooding. Also, EA are engaging with Wiltshire Wildlife Trust and Wessex Rivers to explore longer term, larger opportunities for land improvement to combat rural run off. Some funding available from the EA to the wider Nadder area through the Wiltshire Rural Run Off project. Limited powers as land is privately owned; the EA and Wiltshire Council can only advise local landowners on land management strategies to mitigate run off causing flooding.

Salisbury

Sven Hocking

Currently reviewing flood plans; added flood resilience to Area Board environment working group to improve flood prevention, communication, and early response. Request meeting with Parish Council, EA, and Cllr Hocking to discuss early response to floods and potential flood defences in The Close.

Concerns over flooding in underpasses which are National Highways assets.

Drainage needs to be assessed. With the Salisbury City centre improvement build coming to a close the rest of Salisbury will be looked at. Potential for Property Floor Resilience (PFR)

Cathedral Close

Anthony Wheeler

Some groundwater, but not enough to prevent hosting several events for Christmas and Easter. Wishes to be kept up to date with any developments.

Easterton

Andy Colley

On 28 March large flood event with 11 properties and 1 business internally flooded. Around £300,000 - £500,000 of damage. Wishes to become more resilient. Frustration that no scheme has been put in place previously. Watercourse in High



Street needs maintenance works undertaken on silted gullies in High Street; is on the EA maintenance schedule. EA to investigate.

Following the events of the 28th landowners are more willing to engage with EA regarding land management.

Upper Deverell's

Belinda Stewart-Cox

No properties internally flooded this winter but many near misses. Much concern from residents communicated to the Parish Council. The B3095 drain clearance has worked well. Local landowner has dug two 2mx1m soakaways and has already had to dig them out this winter due to silt from the road. Currently mapping drainage assets in the Upper Deverill's Found 3 or 4 half buried drains in Brixton Deverill. Can we get them cleared and jetted?

Flood waters have washed away verges causing a sudden drop from the edge of the road. Needs reporting on MyWilts.

Working with Wessex Rivers to upgrade septic tanks in the valley as a part of the Chalk River scheme.

Swallowcliffe

Barry Fitzpatrick

Parish Steward has visited to help clear gullies with Flood Working Group. Waiting for Gully Tankers to attend. Needs dredging of major ditch in village centre on Bottom Road which is blocked and impedes water flow to culvert causing flooding on the road. Undertaking remedial works to prepare for next major rainfall. Chase date of dredging.

Great Bedwyn

Jonathan Hitchman

Reports success of schemes at the allotments and in Lower Church Street, both have worked well. Needs to be kept clean for them to work. Brook Street have 5 internal flooding and 10 external flooding, some over 50cm. Working with Canal and River Trust and Wiltshire Council Highways and land agent to clear culvert. Ditches need maintenance. Met with Landowners with positive outcome. Hoping to reach flood management solution. Needs topographical survey to engineer solutions. Once completed will need Drainage engineering advice on how to manage flows.



Corsley

David Ball

Soil is green sand resulting in many near misses, had 3 landslips in three different lanes and a tree washed into the road. Longleat own the land and they have not cleared the ditches. Cannot get a digger onto the land to clear. Lots of field run off depositing silt onto the road in Sturford Lane. Only one drain which is overwhelmed by the water and silt. Meeting including Longleat Estate and Council officers in early June. Longleat has suggested planting Hazel on the banks to prevent landslips.
