HC/25/005 Minutes

HC/25/005.1 The minutes of the Highways Advisory Committee meeting, held on Monday 9th December 2024 were approved as a true record and signed by the chairman.

HC/25/006 Chairman's Announcements

HC/25/009 Reports from Unitary Authority Members

HC/25/010 Matters Arising from the meeting of the Local Highway and Footway

Improvement Group (LHFIG)

Members noted the updates from the LHFIG meeting on 22nd January 2025.

HC/25/011 Highway Improvement Form Requests

11.1 Deverill Road/ Marsh Street

Members resolved not to pass the proposal to the LHFIG commenting that there had been no significant changes since they last considered the matter and requested that a letter be sent to the resident.

11.2 Smallbrook Lane

Members resolved to ask the resident to reapply to the Highways Advisory Committee when the development on Smallbrook Lane has been completed, should there still be a problem, commenting that vehicles causing the problem would be exempt from any height/ weight/ speed restrictions imposed as they would be servicing a property. The resident could instal a sign on her own property should they wish to.

11.3 North side of Westbury Road

Members resolved to negotiate with Wiltshire Council to repaint the existing signs or to instal three new signs on the verge – to be funded from the council budget line for LHFIG work - but not to pass the proposal for double yellow lines to the LHFIG.



11.4 Imberwood Close Estate

Members resolved to investigate whether the road has been adopted by Wiltshire Council, meaning that they take ownership and responsibility for maintaining the road, noting that 'No Parking' signs had been erected by the management company, but not to pass the proposal for double yellow lines to the LHFIG.

HC/25/013 20mph town centre speed limit surveys

Members noted that the results of the surveys to collect vehicle and pedestrian data in the town centre would form part of a 20mph speed limit assessment report to be presented to the LHFIG at their June meeting. Warminster Town Council would then consider the implications.
