


FC/25/067 <u>Councillor Allowances</u>



Mid-June you would have seen Warminster Neighbourhood Policing team out and about carrying out various community events to showcase what your local NPT do behind the scenes.

The team have carried out numerous community drop ins across Warminster, attended local fetes, held tack stamping drop ins.

The Mobile Police Station was out and about across Warminster the week of 16th June and some locations were very successful with members of the public seizing the opportunity to speak to their local officers.

The White Audi that was causing a number of traffic related issues within Warminster was dealt with by our Trowbridge Response team and Roads Policing Team. He was arrested for a traffic related offence and his vehicle was subject to a Section 59 Notice.

I have since been informed that this male has now changed this vehicle. We will continue to monitor any new reports made.
