13 new volunteers have been given litter pickers, counters, etc. Each has a designated area and each individual is reporting in figures of how much litter they collect. In October it was 18,236 pieces of litter. More volunteers are always welcome.

The litter pick for World Clean Up Day on 20 September went well.

Councillor Jones hosted series of talks showcasing sustainability and conservation projects at the Wellbeing Hub in Warminster on Saturday 8th November. These were very informative and well attended and there will be another series of talks in 2026.

Sadly, there seems to be an increase in dog fouling in some parts of the town.
