Public Participation

Maggie Daniels spoke regarding the future of the town and its heritage assets. She had previously attended a planning meeting about the potential purchase of the land at 3 High Street for an open green space at the Chapel St Lawrence so it would not be blocked by the proposed new development. This idea has since progressed, and a Community Interest Group is being established. The group would seek funding from grants and donations and if the bid for the site at the side of St Lawrence Chapel failed the monies raised would be used for other heritage sites within the town.

Cllr Carter spoke regarding the Town of Culture and thanked the committee for the opportunity to speak.

A Culture competition is about more than size, geographical location or aesthetics, it is about community identity, shared customs and beliefs as well as civic pride. While the prize money is attractive, an application to this competition is not just about prize money - this is about putting Warminster on the national map and showing people that have never visited exactly what makes this town so special.

Our story stretches from the Iron Age hillforts of Cley Hill to our Saxon origins as a Royal Manor. We are a town of pioneers: home to the Warminster Maltings, Dents, and a renowned Cornmarket legacy. Historic architecture can still be admired today with shops on our high street located in buildings first opened in 1499. We have the Athenaeum Theatre, a jewel of Victorian architecture and the beating heart of our local arts. We have the Lake Pleasure Grounds, a space that brings families together across generations and is renowned in the Southwest.

And let’s not forget our modern folklore—our town is known as the ‘UFO capital’ of the UK, a unique part of our identity that shows our community looks to the stars with curiosity and imagination.

There are plenty of other cultural elements that we can and should touch on, and I hope that you approve the opportunity for our Town to take that first step and to

allow others interested in expressing our culture, both current and historical, the opportunity to do so.

What could we achieve with the Prize Fund?

The bid application talks about local challenges and issues that our bid can help to address. I have put forward 3 of my own but it is my hope you as a committee can decide upon and implement more detailed ideas:

1. Revitalise our high street further through creative hubs, workshops and small independent businesses.
2. Improving the scale and possibly number of the independent markets and bringing more sports and music related events to the town park.
3. Increase spending on the wellbeing of our youth population through programs and workshops in the arts, or utilising our natural assets to link the culture of our town with mental health and the environment

If we don't apply, we guarantee that this investment and prestige goes elsewhere. If we do apply, we show the people of Warminster that their council is ambitious for their future, and that we believe in Warminster as a town of culture and potential.

TD/25/070 **Grovelands Countryside and Wildlife Volunteers**

Len Turner updated the committee on the water voles in the vicinity of the Grovelands, there had been early sightings which proved what a mild winter it had been. There are burrows being spotted which is a good sign for the population. He advised that there was still silt washing down from the Persimmon site. There had been measures introduced to reduce the silt by using straw bales, this is no longer working, so he will continue his dialogue with the developers on how to reduce the silt washing down into the town park, Smallbrook and the River Wyllye.
Members noted the updates from the Grovelands Countryside and Wildlife Volunteers and requested that their thanks be passed on to all involved.

Members decided that they wished for Warminster to submit an Expression of Interest and apply to enter the UK Town of Culture competition, a new Government initiative which aims to shine a spotlight on the unique contributions that towns make.

Members approved for an Expression of Interest be submitted to the Town of Culture Competition by 31st March 2026 and set up a working group to meet next Monday 9th March comprising of Cllrs Allensby, Barnes, Carter, Jones, Keeble and Chair of Warminster Business Network Matt Towl.
