9. Warminster Arts Week

In 2020, the town council gave a grant for a Warminster Arts Week project. This was paid to Warminster and Villages Development Trust as fund-holders for the applicants. The grant was £2,000 of which £335.64 was spent, leaving an unspent balance of £1,664.36 which has been returned to the town council. The sum of £1,664.36 has been added to the grants' budget for 2024/25.

The aim of Salisbury Plain Rights of Way Volunteers (SPROWV) is to provide Certainty, Clarity & Consistency to rights of way are and to help maintain them where possible,

SPROWV started on SPTA and since 2008 have inserted repaired or replaced > 2,000 rights of way signs across Central & South Wiltshire..

SPROWV also clear and repair rights of way but nearly all in Warminster. The mowing is conducted almost entirely by Nigel Linge and almost all of it is in Warminster.

Please give details of what you want to buy with/use the grant for.

Wiltshire Council gives poor service on mowing rights of way. The Town Council has a power to maintain rights of way & Nigel has been mowing paths in the town for 10 years.

Our 20 HP Field and Brush Mower was bought with an Area Board grant in 2018 and is now at end of life and very expensive to repair. Spares are three times what they cost in 2018 and the mower is currently not safe to operate.

The replacement is a copy of the existing machine but the numerous weaknesses have now been designed out e.g. handlebars and cables are now much more rugged.

I work with an extended group of friends within the Rights of Way community on signing & route clearance projects plus the Ramblers & Smallbrook Volunteers in Warminster & surrounding villages. I am cleared to work by Wiltshire Council & MoD as part of a Tr-Partite agreement with MoD & Wiltshire Council.

We do not have a constitution or the other documents you suggest below.

A well-maintained rights of way network encourages people of all demographics to take exercise and enjoy our town and countryside.

I am working with the Town Clerk to make those who fence in paths to then maintain them iaw Section 36 (4) of the Highways Act 1980. We are also working on making property owners cut back their hedges.

Warminster rights of way number up to WARM93. I have had 3 successful claims for rights of way, am assisting with another in Woodcock Gardens and have another in the chain between Folly Lane & Cannimore Lane. I have a number of outstanding claims in surrounding villages that extend the network.

I mow all paths (Row & Permissive) at Smallbrook Meadows and most other grass paths/bridleways in Warminster that I have not encouraged others to mow e.g. MoD, Longleat & the Golf Club.

The project is also inserting destination signs around the town. Working with Longleat, Horningsham & Corsley Parish Councils we have signed bridleways linking Warminster to Corsley, Upton Scudamore & Longbridge Deverill.

While my mower is unserviceable, I cannot mow.

What is the timescale for your equipment purchase/activity/project? If the cash is granted on 2 September, I can have my new mower and be operating withi a week.


