

Councillors,

You will know Smallbrook Lane as a quiet lane for dog walkers, horses, cyclists, and many other pedestrians (including unaccompanied children in the summer) accessing Smallbrook Meadows and the lake and play area beyond.

It is also used as vehicular access for residents of Smallbrook Lane and those in Boreham Road with garages on it. All these drivers understand its multi-use character and drive slowly.

The safety of all the users, especially the children, dogs and pedestrians, has come under threat since the residence at No. 20 was put up for sale. As you know, it was granted planning permission and is now being developed. Traffic to this site was one of the reasons for objection - mainly brought to our attention by the inappropriate speed of the developers!

Even though this is still winter, and not much development has so far happened, there have already been several instances where speeding vehicles along the narrower stretch have almost caused injury to dog walkers. In this case 'speeding' is defined as inappropriate speed for the conditions (and in one witnessed instance at least, probable illegal speed).

In summer the use of the lane increases enormously. People wander down this lane thinking it is safe from traffic. Obviously, if they are actually on the lane they can be seen by drivers. There are however two exits from Yeates Field where the visibility splay is minimal and children and dogs tend to rush down into the lane. One is on the narrower part where there is no room for both vehicle and pedestrian.

As residents very familiar with the situation we are very worried that an actual accident will happen.

We would like you to support and promote safety measures here, and maybe to make it officially a 'Quiet Lane' - as it has been, unofficially, until recently.

Highways no doubt has a range of options to make it safer, but we thought a speed reduction sign would at least be a signal to unfamiliar users that this is not a normal road.


Delivery drivers also come into this category, and would no doubt increase in number when the new house is occupied.

(The previous owner was a recluse so there was virtually no traffic before.). In the meantime the biggest threat comes from unaware drivers of development vehicles of all sorts.

I am therefore submitting a Highways request via the Town Council, for a speed reduction and to consider making Smallbrook Lane officially a Quiet Lane. This has community support, as demonstrated by the local residents in the form of a petition, and from conversations with users of Yeates Field.

We also need to try to make Highways aware of the likely danger this summer, to see if some measure(s) can be put in place as a stop-gap.
